FRIDAY AFTERNOON

The meeting was called to order by the Chair, Bishop Katharine Jefferts Schori. She introduced and welcomed new Council member Bryan Krislock. Bryan was appointed by Province VIII to fill the vacancy created by Ted Yumoto's resignation.

Bishop Katharine then called on the Secretary, Gregory Straub, for announcements and the roll call. Gregory read a letter from Lee Alison Crawford explaining that the reason she is absent is to minister to a dying parishioner. The deadline for the consent calendar is 2:45 p.m. on Saturday.

Bishop Katharine presented the agenda, and it was accepted. An addition to the minutes to include the names of ratified ERD Board members was announced. A motion to accept the minutes as amended was seconded and the minutes were approved.

REPORTS FROM COMMITTEE CHAIRS

JOSEPHINE HICKS – ADMINISTRATION & FINANCE

A&F will discuss building-related issues, archives relocation, requests from ECCIM and Navajoland for more funding, and grants accountability.

TERRY ROBERTS - CONGREGATIONS IN MINISTRY

CIM will consider Constable Grant applications, and will hear from Bud Holland and Matthew Price about the work of the task force studying Employment Practices.

SANDI MC PHEE - INTERNATIONAL CONCERNS

INC will spend time discussing the budget and the Anglican Covenant and will hear reports from David Copley on missioners, Elizabeth Beach-Hacking on UTO and the Conversation on Anglican Churches in the Americas.

JOHN VANDERSTAR – NATIONAL CONCERNS

NAC will discuss the budget, hear a report from Hisako Beasley about the PB's Summit on Domestic Poverty and view a video from Jayne Oasin on anti-racism. They are preparing a resolution on cluster bombs and another urging prayers for the bishops as they travel to Lambeth.

TASK FORCE REPORTS

Bonnie Anderson reported on the work of the INC 005 Task Force. There will be a conference in Costa Rica from February 22-29, 2009, and the keynote speaker is John Kafwanka from the Anglican Communion Office.

Vicki Garvey will report for A&F059 later in the meeting.

Del Glover reported that the work of Task Force A110 is ongoing, and they will have a report in October.

OPENING REMARKS

Katharine Jefferts Schori told of her travels, both domestic and international, since the last meeting, and the need for advocacy voices. She also spoke of the upcoming Lambeth Conference and the opportunities the bishops will have to be together.

Bonnie Anderson began by asking Belton Zeigler to stand and everyone sang "Happy Birthday". She then discussed her work on Mission and Identity, including the Public Narrative project. The website for the President of the House of Deputies has been launched and will be constantly updated with information for deputies as we move toward General Convention.

Linda Watt gave an update on staffing and the regional offices. She introduced the new in-house attorney, Tom Duggan, and Bill O'Connor of PPM Building Services. She announced that Susan McCone is now the full time Director of Mission Funding and Solange DeSantis has been hired as the new editor of Episcopal Life. The Los Angeles regional office is up and running, and offices have been set up in Omaha, with Bishop Chris Epting working there at least one week per month. They have tentatively settled on some space in Seattle and expect that to be finalized soon. No decision has been made regarding a regional office in the south, but there is still hope that they will locate space in Atlanta. The Office of Black Ministries and Asian Ministries will stay in New York. July 9th is the roll-out date for Phase 1 of the re-designed website with improved search capacity. Linda thanked Su Hadden for all her work on the building restructuring and asked Brian Grieves to say a few words on behalf of the four Center Directors.

Brian reported that April 7th was the official date that the new structure began. He noted that each center had a staff retreat and he was able to attend all of them. The Center Directors meet weekly or bi-weekly and are open to hearing the concerns of people.

There was a break and then time for private conversation. After private conversation, the plenary session was adjourned and the rest of the afternoon was spent in committee.

SATURDAY, JUNE 14, 2008

The morning was spent in committee

SATURDAY AFTERNOON

Bishop Katharine called on Gregory for announcements. Butch Gamarra relayed a message from Wilfrido Ramos-Orench, thanking everyone for the cards, prayers and good wishes and gave his address in Connecticut, should anyone wish to contact him.

Executive Council members and staff participated in an anti-racism exercise facilitated by Ed Rodman.

Gregory Straub read the consent calendar – A&F 061, A&F 062, A&F 063, A&F 065, A&F 066, CIM 019, CIM 020, CIM 022, CIM 023, CIM 024, CIM 025, CIM 026, CIM 027, CIM 029, CIM 030, NAC 031.

Next, Steven Hutchinson made a presentation on behalf of the task force charged with the revision of Title IV. Advance materials had been distributed so that Council members were able to familiarize themselves with the work of the task force and the proposed revisions. Mr. Hutchinson explained the structure of the proposed new model. They seek reconciliation as their model, and seek to promote pastoral responses in healing, hoping to spend more time and energy on how to proceed rather than on what happened. There was opportunity for questions after the presentation.

Terry Roberts gave background information on Public Narrative, telling how Bonnie make a proposal to CIM about learning the ability to tell our stories and be active listeners to others. Bonnie expanded on that, saying that using the theme of Ubuntu, we are going to explore the learned art of public narrative. With that, she introduced Marshall Ganz. Marshall explained that public narrative is a leadership art that inspires action and consists of three elements, plot, character and moral. It is learning to tell a story of self, story of us, and story of now. Marshall and his facilitators will be at each of the provincial synods giving an introduction in the first step of public narrative to prepare participants for the Mission Dialog to take place at General Convention.

SATURDAY EVENING

Dinner on Saturday evening was preceded by presentations from representatives of the Diocese of Rio Grande and Province VII.

SUNDAY MORNING, 6/15/08

The Executive Council was split into two groups; one attended worship at St. Michael's and the other at St. John's Cathedral.

SUNDAY AFTERNOON

CONGREGATIONS IN MINISTRY – TERRY ROBERTS

Terry began by thanking Joyce Hardy and Butch Gamarra, as well as the rest of the committee, for all their work. CIM heard a report from Bud Holland and Matthew Price on Employment Practices for Lay People and learned that lay employees are not treated as well as clergy as far as health insurance and pension are concerned. The committee heard staff reports from Margaret Rose, Suzanne Watson, and Bud Holland, and discussed the Constable Fund grant applications. Explanation

Mike Maloney, the interim Executive Director of Episcopal Appalachian Ministries (EAM) met with Bishops Von Rosenberg (East Tennessee and also chair of the EAM Board), Price (Southern Ohio), Klusmeyer (West Virginia), and Sauls (Lexington) about their common interests in ministry in Appalachia on May 29, 2008. The subject was the recognized need to reform and reshape EAM, a process the Board of EAM has already undertaken with enthusiasm and a desire to continue to be a positive force in the Appalachia and with respect to concerns in the Appalachian region.

With that goal in mind, the recommendation was made to use Episcopal Church funding designated for "Appalachian Initiatives" to make direct grants at the direction of a grants committee composed of bishops and laypeople of dioceses involved in Appalachian ministry. In 2008, 60% of the "Appalachian Initiatives" funding would be used to make direct grants and 40% used to support EAM. Thereafter, the total amount for "Appalachian Initiatives" would be used to make direct grants to support ministry, if there are grants given.

International Concerns discussed budget priorities being mindful of fiscal constraints and looked at alternative ways of securing funds. They heard from Bonnie Anderson about the work of the Task Force on the Americas and from David Copley about the missionary program. Following up on their discussion of UTO in Quito, they heard from Elizabeth Beach-Hacking and held extensive discussions on the future of the UTO. The Presiding Bishop has formed a task force, and there will be a report from that task force in October. Toni Daniels reported on the Advocacy Center. Rosalie Ballentine spoke about developing a response to the St. Andrew's Draft. Ian Douglas gave an update on the Lambeth Conference. Sandi moved the following resolutions:

Resolved, That the Executive Council, meeting in Albuquerque, New Mexico, June 13-15, condemns the use of cluster bombs and calls upon all governments, including our own governments, to negotiate and sign an international treaty prohibiting their production, transfer, stockpiling, and use.

Explanation

Cluster bombs are containers filed with smaller bombs (bomblets or submunitions) that are dropped from the air or fired from land or sea. They were first used in World War II and are now stockpiled by at least 76 states and have been used in at least 31 countries and disputed territories. Experts point to 210 different types of cluster munitions including projectiles, bombs, rockets, missiles, and dispensers. They open in midair and the bomblets then spread over a large area, sometimes the size of two to three football fields, killing or injuring those on the ground, regardless of whether they are combatants or civilians. Those bomblets that fail to explode on impact remain on the ground, like unexploded landmines, and are a continuing lethal threat to all living in the area. Billions of submunitions are now stockpiled and ready to be used by more than 70 countries.

In Vietnam, it is estimated that up to 300 people die annually from cluster bombs and other objects left by the US and South Vietnamese military forces. In post-war Kosovo unexploded cluster bomblets caused more civilian deaths than landmines. When 18 people were killed and 136 wounded by U.S. made cluster bombs after the cease-fire following Israel's war with Lebanon in 2006, the State Department launched an inquiry into their use. That inquiry has not been made public. Locations affected by cluster bombs include: Afghanistan, Albania, Bosnia and Herzegovina, Cambodia, Chad, Croatia, Eritrea, Ethiopia, Iraq, Kosovo, Kuwait, Laos, Lebanon, Montenegro, Russia, Saudi Arabia, Serbia, Sierra Leone, Sudan, Syria, Tajikistan, Vietnam, and Western Sahara.

Unlike land mines, there is no international legal instrument that covers cluster bombs and some countries, including the U.S., consider them legitimate weapons. The Government of Norway has convened international meetings to pursue a treaty banning cluster munitions that "cause unacceptable harm to civilians." On May 28, 2008, over 111 nations meeting in Dublin completed negotiations on a new international treaty that commits their governments to stop using cluster bombs and to destroy their existing stockpiles within eight years. The agreement also calls for strong standards to protect those injured by them and to make sure that contaminated areas are cleaned up as quickly

as possible and that the weapons are immediately destroyed. The United States did not attend the meeting. Other countries not signing the ban or attending the meeting were China, India, Israel, Pakistan and Russia – all users or producers of cluster bombs.

Proponents of cluster bombs, such as the United States, argue that they are highly effective in combat against certain targets. The United States and Britain have used them in Iraq, but Britain broke with the U.S. and signed the treaty in Dublin. Questions of international humanitarian law come into play as cluster munitions users must weigh "proportionality" of military advantage versus civilian impact. That impact, however, is particularly high with cluster bombs because of the large area they contaminate and the danger subsequently of those that fail to explode. According to the Washington Post, "U.S. officials argue that technological advances will ensure that future cluster bombs reliably explode or quickly disable themselves, so they will not be a hazard to civilians later." Presently the U.S. cannot export cluster bombs because of a law requiring that they detonate at a rate of 99% - current versions do not do so.

According to the New York Times, more than 40 million land mines have been destroyed since that treaty went into force, trade in land mines has "virtually ended," and only Russia and Myanmar were still using them as of 2007.

Within the Anglican Communion, the Provinces of Aotearoa, New Zealand and Polynesia, the Episcopal Church of Brazil, the Anglican Church in Hong Kong, the Church of Melanesia, the Church of Mexico, the Scottish Episcopal Church and the Church in Wales are all supporting the ban.

Other notable factors about cluster bombs

- Cluster bombs cause death and injury to civilians not only during war and conflict but for years following; one-third of all recorded cluster munitions casualties are children who are attracted to their small size, sometimes bright color, and curious shapes;
- 400 million people worldwide are estimated to be threatened by cluster bombs in their areas, and 60% of cluster bomb casualties occur during everyday activities;
- The existence of cluster bombs hampers post-conflict rebuilding and rehabilitation; their removal being costly and dangerous and uses funds that could be spent on other urgent humanitarian needs;
- While many nations have used cluster munitions, the U.S. has been the largest producer, stockpiler, user and exporter of them;
- The Episcopal Church at its 71st General Convention in 1994 called for "an international ban on the use, production, stockpiling, and sale, transfer, or export of antipersonnel mines," munitions that similarly endanger civilians and contaminate land.

Report from International Concerns Committee

Date: 15 June, 2008 Re: Missionary Support The International Concerns Committee (INC), meeting in Albuquerque from June 13-15, 2008 received a report from The Rev. David Copley, Director of Mission Personnel regarding current financial support needs for Appointed Missionaries, Volunteers for Mission and Young Adult Service Corps missionaries of The Episcopal Church, serving around the world.

The Director of Mission Personnel indicated that rising costs due to increases in pension and health insurance for missionaries combined with a static budget will result in a long-term reduction in the numbers of missionaries supported by The Episcopal Church. He further indicated that a significant evaluation as to the way that The Episcopal Church supports missionaries needs to be undertaken.

Conversations have begun with the Standing Commission on World Mission (SCWM), Episcopal Church Center staff, and current and former missionaries, as to the best way to address this difficulty. As a result a Working Group on Missionary Support made up of staff, and members of both the SCWM and INC, and chaired by the Director of Mission Personnel will provide suggestions as to how support for missionaries can be guaranteed in the next triennium.

INC expressed appreciation for the efforts of the Working Group and offered to cooperate with the Working Group as appropriate. INC looks forward to hearing a report from the Working Group as to how INC can supports its finding, particularly in the drafting of our Blue Book Report with resolutions.

We rejoice in the fact that Lambeth 2008 is designed to equip the bishops for leadership in God's mission and strengthening the Anglican Communion through discussion and conversation grounded in the reading and study of Holy Scripture, invoking the presence of the Holy Spirit in all that they undertake, and respecting the Biblical admonition that we are all one in Christ Jesus (neither Jew nor Greek, male nor female, slave nor free).

Although these structured discussions will not include the voice and face of the Bishop of New Hampshire, who has not been invited to participate, we pray that his voice will be heard through those who are there speaking the truth about The Episcopal Church and hearing the truths of others, to the benefit of the wider Communion.

We look forward to our bishops' safe return and the opportunity for all of The Episcopal Church to engage them in discussions of their experiences at Lambeth 2008 in order to enrich the Church's understanding of and consideration of matters vital to our common life in Jesus Christ.

This concluded the report from National Concerns.

ADMINISTRATION AND FINANCE – JOSEPHINE HICKS

Josephine began her report with a discussion of A&F 064. Rosalie Ballentine asked what the status of the Archives move was, and Pan Adams answered that they have made an offer on a property in Austin.

In discussing the proposed DFMS budget for 2007, committee Minutes reflect that due to "...The pressing need of the Archives to mount a feasibility study for major fund-raising was raised and agreement reached that \$150K per year of the triennium should be added to the budget..."

That amount was added to the 2007 budget but was not spent. At 12/31/07, the Finance Office accrued the total amount but the external auditors asked that it be reclassified as a

credit to 2007 earnings. The effect was to restore the \$150K to short-term reserves. Anticipating the availability of this unspent amount, no allocation was included in the 2008 budget.

The Archives Strategy Committee has increased its work in 2008 and expects additional funds will definitely be required when we have land under contract and have a clearer idea of costs for due diligence and fundraising.

In introducing A&F 067, Josephine said that the committee asks the Presiding Officers to appoint a task force that includes someone from A&F and someone not from A&F.

The expectation is that the members of General Convention will arrive at a missional understanding of their role together as the church. Having experienced the four sessions, members of Convention will be equipped to replicate the exercise in their dioceses and parishes.

Council was reminded that budget requests will still be coming in. John Vanderstar asked if there would be discussion with staff before the budget proposals go in, and Kurt responded affirmatively. Josephine said that in October, Council will look at a draft budget.

Vicki Garvey reported on the work of Task Force A&F 059. The task force, consisting of members of A&F (Vicki Garvey and David Alvarez) and INC (Julio Holguín and Timothy Kimbrough) with help from Skip Windsor of the Audit Committee, were charged with developing a process to ensure accountability and evaluate outcomes with respect to block grants. They have come up with seven questions to be asked for each grant and implications for non-response.

On behalf of the Audit Committee, Stacy Sauls reported that the audit was received and accepted by the committee and that the Archives has prepared a policy for record retention.

Companion Church Reports

Michael Ingham continues to give thanks to God for the partnership between the Episcopal Church and the Anglican Church of Canada which he thinks represents a model for the whole Anglican Communion. Four days ago, the government of Canada apologized to the indigenous people. The apology was about the residential schools, recognizing that it was wrong to remove children from their homes and separate them from their parents. In his apology, the Prime Minister said that these institutions gave rise to abuse and neglect and for this we are sorry. This was a historic occasion and the apology was brought about by pressure from churches. Michael recently returned from the General Assembly Council where the Anglican Church of Canada adopted their response to the St. Andrews Draft.

Vicki Garvey, as liaison with ELCA, reported that at their last meeting she was awed by their sense of liturgy. There was time for anti-racism training at their meeting, and they also addressed sexism. The final draft of their new sexuality report is available on line.

CLOSING REMARKS FROM CHAIR AND VICE CHAIR

Bonnie Anderson thanked her assistant, Kim Tucker, for all her help and wished the bishops well at Lambeth. She noted some different voices at this meeting and received positive comments for the Public Narrative piece. She was struck by how short the meeting was, and was struck by what Michael Ingham had to say about the indigenous people. How can we become advocates for the indigenous people? Bonnie would like to get a group together to discuss this and feels we need to take a good look at our relationship with the indigenous people. She ended with a quote from the Hope Indians:

Message from the Hopi Elders

You have been telling the people that this is the Eleventh Hour.

Now you must go back and tell people that THIS is the hour.

And there are things to be considered:

Where are you living?

What are you doing?

What are your relationships?

Are you in right relation?

Where is your water?

Know your garden.

It is time to speak your truth.

Create your community.

Be good to each other.

And do not look outside yourself for the leader.

This could be a good time!

There is a river flowing now very fast.

It is so great and swift that there are those who will be afraid.

They will try to hold onto the shore.

They will feel they are being torn apart, and they will suffer greatly.

Know the river has its destination.

The elders say we must let go of the shore,

Push off into the river.

Keep your eyes open.

And our heads above the water.

See who is in there with you and celebrate.

At this time in history, we are to take nothing personally,

Least of all ourselves.

For the moment that we do, our spiritual growth and journey

Comes to a halt.

The time of the lone wolf is over. Gather yourselves!

Banish the word struggle from your attitude and vocabulary.

All that we do now must be done in a sacred manner and in celebration.

We are the ones we've been waiting for.

The Elders Oraibi, Arizona Hopi Nation

Katharine Jefferts Schori spoke about the things that struck her at this meeting. One was the discussion of missionaries and the thought that maybe the days of sending people out as missionaries is over. Another was the increase in companion dioceses – we can learn a great deal more about each other – and also the resolution asking the whole church to hold the bishops in their prayers as they go to Lambeth, with the focus on the whole, rather than the individual not invited. Bishop Katharine gives thanks to the work of this body and their sense of cohesiveness.

The meeting was adjourned at 4:30 p.m.
