#### **Consultants Reports:**

A. Holley

- Shared the multi-approach fundraising which is occurring for St. Aug.
- P.B. Absalom Jones Appeal netted approximately \$30,000.00 to be distributed equally to both HBCU schools
- There are three Fundraisers planned for May in North Carolina
- Possible Fundraiser to be held in D.C., possibly in June
- A major donor list is being created
- Reported that Dr. Ward is traveling and had recently been in Virginia where he raised between 10,000 15,000.
- Shared a list of prospective donors (not to be shared or circulated)
- William White is a very good potential donor for St. Aug.

### B. Lang

- Recently met with two South Carolina bishops and Dr. Evans. From this meeting, it was determined that there is a lack of understanding between Voorhees and the Episcopal Church. Structure, roles, responsibilities, and expectations are not clear. The Chair was asked to make contact with the two bishops to work on clarification. (Fr. Ron Byrd has expressed that he would like to be a part of the dialogue). Dr. Evans is not as knowledgeable and connected with the Episcopal Church as was Dr. Sellers (an Episcopalian).
- Giving, Enrollment, Retention are all up at Voorhees. The school seems to be doing very well. Things are very positive.
- Re: St. Aug Final plans with Reese Financial are being completed to secure the 1st \$1 million loan. Should close in approx. 2 3 weeks. The second loan is hoped to close in approx. 6 weeks.
- Things appear to now be cautiously optimistic at St. Aug
