Task Force Business

Opening of Meeting

The Rev. Tom Brackett opened the meeting and announced that he facilitate the meeting given the Rev. Canon Janet Waggoner's absence with a reading from the Lao focused on pilgrimage and the approach of the sacred. Following the reading each of the members of the Task Force responded to the question, "What's most alive for you right now?"

Update on Existing Business - Church Planting

The Rev. Mike Michie gave a presentation on church planting that included a report on upcoming discernment retreats, a review of promotion material for New Episcopal Communities, and celebrating a recent conference.

The following suggestions were made in regards to the promotion material for New Episcopal Communities:

- The Rt. Rev. Gretchen Rehberg: Noted the lack of clarity in describing "new communities or dioceses" and suggested that be clearer as to not suggest that there is a new diocese forming.
- The Rev. Daniel Velez-Rivera Request to clarify that by new we do not mean "never been done" but new as in "not supporting a currently ongoing ministry in this context."

Decision to Extend Funding

The Rev. Mike Michie requested an extension on the remaining funding appointed to the Dinka Language Ministry (\$6,666.66) through the next triennium so that they can buy supplies on an upcoming trip to the Sudan. The Task Force unanimously agreed to extend the funding.

Update on Existing Business - Congregational Redevelopment

The Rev. Tom Brackett then gave a report on the updated progress of Congregational Redevelopment Work that included a request to read and review a letter for the House of Bishops that follows-up on an email sent in 2018 introducing the Congregational Redevelopment Work and an update on a conversation with Nancy Davidge about the website.

Note that in his report the Rev. Tom Brackett mentioned the need for a glossary but we did not follow-through this this request and may need to bring it up again in our next meeting.

Update on Existing Business - Communications

The Rev. Dr. Gray Lesesne then presented on the work of the communications subgroup that includes suggested edits to the webpage, a press release about discernment retreats, and a rough draft of theological grounding.
