# ACCESSIBILITY GUIDE & INFORMATION

## Baltimore, Maryland

The Executive Office of General Convention, in consultation with Visit Baltimore, the Diocese of Maryland, and the Task Force on Disability and Deaf Access, offers the following information for General Convention guests with disabilities.

### **Baltimore Convention Center Accessibility**

The Baltimore Convention Center (BCC) is an ADA-compliant facility and is committed to ensuring that the venue is as convenient, accessible, and enjoyable as possible. The BCC is responsible for the permanent building access requirements: such as, but not limited to, wheelchair ramps, elevator standards, restroom standards, and internal hallways and doors in addition to the following accommodations:

- Sidewalk curb cuts into main lobby areas
- Thresholds at each entrance which are level with the floor
- Standard wheelchair accessible restrooms
- Exterior automatic sliding doors
- Emergency systems which provide both flashing strobes and voice alarms
- Meeting room signs equipped with Braille indicators
- Elevators equipped with Braille indicators, chimes, and raised letters
- Visual line indicators (flashers) and amplified handsets available through the Center's Telecommunications Department
- Wheelchair lift which raises up to stage level

### **Service Animals**

Service Animals that are individually trained to do work or perform tasks for people with disabilities will be permitted inside the Center. Animals must be licensed and up to date on vetting and appropriate Health Department permits. Baltimore City Health Department can be reached at (410) 396-4398.

There is no charge for this equipment, but you will be required to leave an ID to be returned once you have finished using the equipment. This equipment will also be available at the same location for the Revival on Saturday, July 9<sup>th</sup>.

### **Accessible Parking and Transportation**

#### **Parking**

Parking for persons with disabilities is available in surrounding garages at the Baltimore Convention Center. This is available on a first-come, first-serve basis. Spaces are marked accordingly.

#### **Public transportation ([www.mta.maryland.gov](http://www.mta.maryland.gov))**

Maryland Transit Administration provides fixed route bus and train service throughout the Baltimore area. All buses and trains are fully accessible to persons with disabilities. Reduced fares are available to persons with disabilities.

#### **Taxi services**

Yellow/Checker Cab operate limited numbers of wheelchair accessible, lift equipped taxicabs within the city of Baltimore. Demand for accessible taxis is significant, however, and availability may be limited at certain times of day. Contact the individual companies to request a wheelchair accessible vehicle.
