Safeguard the integrity of creation and sustain and renew the life of the earth.

 - Advocating for OGR, EPPN, UN
 - Inhibit exploitative extraction practices
- Live-giving
 - Educate people on climate change
 - How do we take up practices in our own lives that commit to the flourishing of life?
 - Carbon footprint

Working Groups Discussion

- A brief history of this group
 - Advisory council on science, technology, and the environment (2012)
 - Advisory council on care of creation (2015)
 - Task force on care of creation and environmental racism (2018)
- Environmental racism (A011) and care of creation (A013) combined for logistical reasons, includes liberating from Canon Spellers's presentation.
- Environmental racism resolution has been around for 2 general conventions.
- Budget lines for A011 and A013 have been combined and approved by Executive Council
 - Although they are together in money, how do we bring them together in the work?
- Mandates talk about governmental law and judicial remedies, but they say nothing about canon law. Maybe it would be beneficial for us to really assess ourselves and walk the walk before we talk the talk.
- The task force should model care of creation in our work by considering carbon offsets for our meetings.
 - TELL THE STORIES. What are we doing, why are we doing it, where is our heart in it, and how can that lead us to Jesus?
 - Episcopal News Service is primed to talk about the environment.
 - Different from press releases!
- We are responsible for coming up with criteria for distributing small grants for eco-justice sites and other grants (Lines 165 and 166 in budget adopted 10/2018)
- Collaboration with OGR?

Moving towards task assignments

- Environmental racism is tied to racial reconciliation. There is a broad spectrum in how it is applied which lead to a discussion and reflection on several points as noted below..
 - For example: Standing Rock. People of Bismark, ND opposed the building of the pipeline by their city because of the potential pollution. Being mostly white, the pipeline was moved to a longer route on the border of the Standing Rock Reservation. The environmental movement changed it from, “don’t pollute our environment” to “no fossil fuels ever” when many of the people worked in the fossil fuel industry.
 - There are environmentalists that have a settler mentality that don’t take indigenous peoples’ opinions into account. Historically the Environmental justice movement is mainly white and highly educated. “Settler environmentalism” is a work of white supremacy rather than taking into account the views of the people who live there.
 - As a Task Force we should take a look at where we are meeting, and who owns the land.

Examples of projects and ideas around the church

- 10 kW solar farm in village in Haiti
- Women’s empowerment in Haiti, selling animals to women at wholesale prices to turn around and sell at market prices keeping the difference.
- Solar Energy Academies
 - Training solar entrepreneurs
 - Employ local people
- Cultivate (Episcopal Food Movement)
 - Creation of network to foster food, faith, farming
 - Many people in agrarian ministries feel isolated and have to reinvent the wheel every time.
 - Growing food for food pantries, rain gardens, *formation*.
 - “Harvesting Abundance, Local Initiatives of Food and Faith” – Brian Sellers-Petersen
- StorySharing
 - Telling stories is a much more powerful method of getting to know people because you can’t discount someone’s story. Allows people to share about faith and difference and opportunities for the disenfranchised.
- Theology of the relationship between the land, food, and faith has been mainly dictated by white male landowners.

- Discussion of tasks relating to grants
 - Creation care is so important that we need to incorporate networks with the small grants system. We can not only provide money, but we can provide support for those who receive the grants.

FINAL

- Perhaps fund new projects that are not yet in development rather than just supporting existing programs
- Organizations need support to be sustainable rather than just one-time funds. “Capacity-building.” Paying for the “boring stuff” that is required to successfully run an organization.
